**Memorandum of Understanding (MoU)**  
**between**  
**University College “CEPS – Center for Business Studies” in Kiseljak**  
**and**  
**İstanbul Nisantasi University, Türkiye**

**Article 1**

In order to promote international cooperation and further their mutual interests in the field of higher education and research, University College “CEPS – Center for Business Studies” in Kiseljak with legal address Josipa bana Jelačića bb, 71250 Kiseljak, Bosnia and Herzegovina represented by the Doc. dr. Selimić Mirzo, Prof. VŠ Director and the İstanbul Nisantasi University located at the İstanbul Nişantaşı Üniversitesi 1453 Kampüsü - Maslak/İstanbul, represented by the Rector Prof. Dr. Ayşegül Komsuoğlu Çıtıpıtıoğlu, agree to sign the MoU between the two universities and agree to establish this Memorandum to cooperate in the following activities:

- cooperation in research activities and development projects;
- exchange of professors, teaching and administrative staff;
- exchange of students;
- exchange of academic publications, textbooks and other data;
- promotion of joint publication of scientific and educational material;
- organizing scientific symposia and conferences;
- exchange of experience in teaching and pedagogic activities, educational programs and innovations in the process of education;
- starting a double diploma program at bachelor level
- provision of studying opportunities in both countries: holders of a master's degree and graduate students, trainees exchange;
- carrying out of joint researches in the fields of mutual interests;
- mutual preparation and publication of teaching aids, scientific and methodical works;
- exchange of information on most important international conferences and symposiums;
- common participation in international programs;
- mutual protection of intellectual property;
- cooperation in improving methodology of the educational process, introduction of advanced international standards of educational activities.

## **Article 2**

The fields and forms of cooperation will be identified separately and they will depend on priorities and financial resources of the institutions. Partners shall agree financial relations when planning and arranging certain events. Details of cooperation will be agreed upon in separate work programs.

The work programs will contain the fields of cooperation, coordinators, details of exchange activities, financial conditions, etc. according to the principles of this agreement.

Partners shall make an exchange of expert delegations in order to work out programs, plans and other joint documents with further approval of these documents by the heads of partner institutions.

Partners shall inform each other about all possible disputes or differences which arise out of the present agreement, and solve them together.

## **Article 3**

The initiatives and projects in this agreement will be realized under the condition that both partners can find the necessary financial resources.

Both institutions will try to obtain financial assistance from the state, the regional government and other public and international organizations and funds.

## **Article 4**

In order to coordinate and monitor the jointly agreed activities, each University shall appoint its own representative. The İstanbul Nişantaşı University appoints Rector Prof. Dr. Ayşegül Komsuoğlu Çıtıpıtıoğlu, University College "CEPS – Center for Business Studies" in Kiseljak appoints, Head of the International Relations Doc.dr. Nermin Palić. The two persons appointed shall periodically monitor the outcomes of this Memorandum.

## **Article 5**

The intellectual property rights arising from the activities realized in the framework of this Memorandum belong to both parties. Publications shall mention this origin. For the activities, which might produce outcomes with economic effects, the Parties shall jointly arrange the property rights and their protection according to their own rules.

## **Article 6**

The agreement is valid for five years from the date of signing and can be renewed for a further four-year period by mutual agreement. The terms of agreement may be amended at any time subject to mutual written agreement by both parties or terminated by either of the parties with a six months written notice.

The signature of the Director of University College “CEPS – Center for Business Studies” in Kiseljak and Rector of Istanbul Nişantaşı University are affixed as acknowledgement and notification of this agreement. The present agreement is signed in four copies; two copies should be given to each partner.
