conclude the following

AGREEMENT ON COOPERATION IN THE FIELDS OF EDUCATION, SCIENCE AND RESEARCH

Article 1

The signatories agree that the purpose of this Agreement is to establish mutual cooperation in the fields of education, science and research, facilitating development, good understanding between nations and long-term international co-operation.

Article 2

In order to achieve the defined objectives and tasks, the signatories agree that the cooperation will be carried out in accordance with regulations valid in the countries of the signatories and in accordance with regulations and criteria adopted by the signatories of this Agreement.

Article 3

The co-operation will be based on providing support to the activities that will be of interest to both signatories, i.e.:

- Exchange of experience in the fields of education, science and research;
- Co-operation in the formation of new study programmes;
- Co-operation and realization of different research projects;
- Possible co-operation in field of publishing joint publications and textbooks, as well as co-operation related to the existing publications;
- Organization of conferences and other scientific and professional meetings on topics that will be of interest to both signatories;
- Enhancement of the education process by facilitating mobility of the academic, non-academic and research staff and students (ERASMUS+, CEEPUS and other mobilities);

Article 4

Organizational, financial and other questions related to all forms of co-operation ensuing from this Agreement will be agreed individually between the persons in charge of a specific issue/department at the school before starting the activity.

Article 5

In order to carry out individual activities as stipulated by Articles 3 and 4 of this Agreement, the signatories agree to provide financial support and to establish other forms of co-operation with national, research, economic and other institutions registered in the countries of the signatories.

Article 6

The expenses ensuing from this Agreement will be covered by the signatories as follows:

- Visits and exchanges - the signatory that sends its delegation to visit the other signatory will cover all expenses arising from the visit of its delegation;
- All other forms of co-operation - the expenses arising from all other activities will be subject to further agreements between the signatories in accordance with regulations of the individual institutions.

Article 7

This Agreement is concluded for the period of four (4) years, and becomes binding on the date when signed by the authorized persons of both signatories.

Article 8

Each signatory is entitled to unilaterally terminate the Agreement at any time provided that the Agreement does not facilitate the realization of the objectives for which it has been concluded and on condition that the withdrawing signatory has bound itself to conclude the ongoing projects and has covered its financial obligations as ensuing from this Agreement.

Article 9

All further changes to this Agreement will be agreed upon in an Annex(ies) signed by both signatories and forming an integral part of this Agreement.

Article 10

This Agreement is signed in four (4) identical copies, of which each signatory receives two (2) copies.
